- Review, decide on and supervise the implementation of investment plans, strategic cooperation arrangements, capital increases in member companies and divestments from investments that are no longer appropriate, ensuring the efficient use of capital and alignment with the Company's development strategy.
- Supervise risk management in the areas of investment, finance, legal affairs and operations; require the Board of Management to regularly assess material risks and develop appropriate control measures to ensure the Company's safe and efficient operations.
- Supervise the preparation and disclosure of financial statements, the performance of information disclosure obligations, related-party transactions, and compliance with laws and regulations on securities, enterprises and other relevant matters.
- Supervise the strengthening of the organizational structure, the appointment of managerial personnel and representatives of the Company's contributed capital at member companies, ensuring that the governance and management structure meets the Company's operational requirements at each stage of development.
- Direct the Board of Management to strengthen corporate governance and review and improve the system of internal regulations and procedures in order to enhance governance efficiency, transparency and internal control capabilities.
- The Board of Directors regularly monitors the Company's business and operational performance, market developments and changes in laws and policies in order to promptly adopt appropriate decisions and safeguard the interests of the Company, its shareholders and other stakeholders.

4. Activities of the BOD' subcommittees:

The Board of Directors maintains the Audit Committee as its sole committee, whose activities are detailed in Section III of this Report. 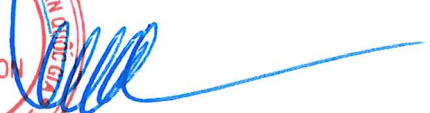
